Christ Church is a small, caring school which is committed to a broad, balanced curriculum and to a continual raising of standards. We aim to contribute to the spiritual, moral, cultural, mental and physical needs of every individual.

We are a Church of England school with a strong commitment to the teaching of Christianity, whilst also supporting a multi-faith approach to the curriculum. We recognise, value and celebrate the rich cultural diversity that exists in our school.

The Christian ethos of the school is reflected in our positive, disciplined and calm atmosphere and in the way that we live our Christian values. We believe that effective learning takes place when children work in a purposeful and stimulating environment that supports a wide range of learning styles. Mutual respect between adults and children promotes excellent behaviour and well developed social skills. With this approach we seek to achieve high academic standards.

We aim to cater for each individual, taking particular account of any specific needs or abilities. AIMS AND OBJECTIVES

The aims of this policy are to:

- Set out what the school will not charge for, what it will make a charge for or request a voluntary contribution towards from parents/carers
- Clarify how charges will be determined, so parents and carers understand why requests for payment are sometimes made for some activities

ACTIVITIES WITHOUT CHARGE

There will be no charge for the following activities:

- Education provided wholly or mostly during school hours. This includes the supply of any materials, books, instruments, other equipment and also transport provided in school hours to carry pupils between school and an activity
- Education provided outside of school hours if it is part of the National Curriculum or part of a syllabus for a prescribed public examination, which the pupil is being prepared for at the school, or part of religious education.
- Instrumental and vocal tuition which is part of the National Curriculum or 'Wider Opportunities' programme.
- Entry for a prescribed public examination (including resits), provided that a pupil has been prepared for it at the school.

VOLUNTARY CONTRIBUTIONS

We aim for all children to go on an educational visit, or welcome an educational visitor, at least once every half term. When organising school trips or visits to enrich the curriculum and the educational experience of the children, the school invites parents and carers to contribute to the cost. All contributions are voluntary. However, if we do not receive sufficient voluntary contributions, we may need to cancel a trip. If a trip goes ahead, it will include children whose parents or carers have not paid any contribution - we do not treat these children differently from any others.

If a parent wishes their child to take part in a school trip or event, but is unwilling or unable to make a voluntary contribution, we allow the child to participate fully in the trip or activity. Sometimes the school pays additional costs in order to support the visit. Parents and carers have a right to know how each trip is funded, and the school provides this information on request.

CHARGEABLE ACTIVITIES

The school may charge for education or activities involving:

- education provided outside of school time that is not:
 - a) part of the national curriculum;
 - b) part of a syllabus for a prescribed public examination that the pupil is being prepared for at the school; or
 - c) part of religious education.
- examination entry fee(s) if the registered pupil has not been prepared for the examination(s) at the school;
- transport (other than transport that is required to take the pupil to school or to other premises where the local authority/governing body have arranged for the pupil to be provided with education);
- board and lodging for a pupil on a residential visit;
- extended day services offered to pupils (for example breakfast club, after-school clubs, tea and supervised homework sessions).

In calculating the cost of optional extras an amount may be included in relation to:

- any materials, books, instruments, or equipment provided in connection with the optional extra;
- the cost of buildings and accommodation;
- non-teaching staff;
- teaching staff engaged under contracts for services purely to provide an optional extra; this includes supply teachers engaged specifically to provide the optional extra; and the cost, or an appropriate proportion of the costs, for teaching staff employed to provide tuition

RESIDENTIAL VISITS

If the school organises a residential visit in school time, or mainly in school time, which is to provide education directly related to the National Curriculum, we do not make any charge for the education or travel expenses. However, we do suggest a charge to cover the costs of board and lodging, although parents and carers who receive state benefits should enquire about support available. If we cannot raise sufficient funding through these voluntary contributions, the visit may have to be cancelled, and that aspect of the curriculum would have to be covered in other ways.

‘SCHOOL JOURNEY’

Every year the school organises a residential trip for the children in Year 6. As this takes part over a weekend, the cost of the trip is determined by the activity centre we are visiting. The total cost will include:

- Board and lodging
- All meals
- Activities and evening entertainment
- Travel to and from the venue

As this price is set by the activity centre, the full cost of the trip must be covered in order for children to attend. Parents will be informed of the cost at the outset of booking and will be offered a wide range of payment plans in order to spread the cost. Parents are encouraged to **speak to the**

school directly if they have any enquiries relating to spreading costs or about financial support available, particularly if they are in receipt of state benefits.

MUSIC TUITION

All children study music as part of the normal school curriculum. We do not charge for this.

There is a charge for individual or small-group music tuition, since this is an additional curriculum activity, and not part of the National Curriculum. These individual or small-group lessons are taught by peripatetic music teachers. We make a charge for these lessons, but parents and carers in receipt of state benefits may be entitled to a 50% discount – this application must be made through the Camden Music Service. We give parents and carers information about additional music tuition at the start of each academic year.

Children in Key Stage 2 have the chance to take part in ‘wider opportunity’ music lessons, which allow them to learn a musical instrument free of charge. As this whole-class tuition takes place entirely in school time, there is no charge for this activity.

SWIMMING

The school organises swimming lessons for all children in Key Stage 2. These take place in school time and are part of the National Curriculum. Therefore, we make no charge for this activity. We inform parents and carers when these lessons are to take place and any questions or issues can be discussed further with the class teacher.

AFTER-SCHOOL CLUBS

Christ Church offers a range of extra-curricular clubs to the children, which take place after school hours. As a result, there will be a small charge for attendance at these clubs to cover the costs of adult supervision and any resources which may be required. If you would like more information about the costs associated with a club, please speak to the school office.

REMISSIONS POLICY

Remissions for trips/ residential visits:

Parents who can prove they are in receipt of any of the following benefits will be considered for discount and in some circumstances the fee will be waived completely.

- Income Support
- Income-based Jobseeker’s Allowance
- Income-related Employment and Support Allowance
- Support under part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit
- Child Tax Credit (provided that Working Tax Credit is not also received and the family’s annual gross income does not exceed £16,190)
- Working Tax Credit run-on (this is paid for 4 weeks after an individual stops qualifying for Working Tax Credit)

- Universal Credit (if the application was made on or after 1 April 2018, the family's income must be less than £7,400 per year – after tax and not including any benefits)

Parents who can prove they are in receipt of any of the above benefits may be exempt from paying the cost of board and lodging for residential visits.

MONITORING AND REVIEW

This policy is monitored by the governing body, and will be reviewed every two years, or earlier if necessary.
